

COOKIES POLICY

PagoNxt, S.L., a company with registered offices in Av. Cantabria s/n. 28660, Boadilla del Monte (Madrid) and holding tax no. B-88136635 (hereinafter, "PagoNxt" or the "Publisher" indistinctively) is the owner of www.pagonxt.com website or sub-domains (the "Website") and hereby informs You, as user of the Website, about its cookies policy, in order for You to be aware of the cookies that will be used while You browse the Website and in order to allow You to consent to said cookies.

This cookies policy (the "Cookies Policy") is supplemented by the Privacy Policy for this Website, which can be found at [Privacy](#).

1. What are cookies?

This Website uses cookies, which are files that are downloaded and stored on your Internet computer (computer/smartphone/tablet) when You visit certain websites and applications, and they are used for storing and retrieving information about navigation using that computer.

The Cookies may serve many purposes. In this Cookie Policy we inform You about the purposes for which PagoNxt uses cookies, depending on the type of cookie. Cookies can be installed either directly by the websites visited by You or by third parties with which the Website is related.

2. Data protection and user consent

In certain cases, using cookies might imply the processing of your personal data, as user who visit the Website. Generally, PagoNxt requires the consent of the users to proceed with the processing activities. For this, the Publisher will previously provide clear and complete information about the use of cookies in particular in respect of the purposes of the processing before such consent is given. This consent will not be necessary in those cases in which the use of cookies is strictly necessary for the operation of the Website.

By accepting cookies, through the mechanisms enabled on the Website for this purpose, or by configuring the cookies, you accept the use of cookies. The Website is accessible without the need to activate the cookies, although if they are not activated some functionalities of the Website might be limited or might not work properly.

3. Types of cookies used

In accordance with this Cookie Policy, PagoNxt will use cookies as described below. You can modify or reject the use of cookies, except for the technical, personalisation or preference cookies, as they are necessary for the basic operation of the Website or for the service requested. The technical, personalisation or preference cookies do not require your previous consent and cannot be deactivated.

This Website uses the following types of cookies:

3.1. Third-party cookies

Detailed below are the different types of third-party cookies, along with their purpose, that may be downloaded to your computer when You use the Website and which are sent to your computer or terminal by a domain or computer managed by a third party other than the Publisher or which are placed by the Publisher even though the information contained in them is processed by a third party. These cookies do not allow the Publisher to identify users who navigate its Website. Information collected by third parties using these cookies is subject to those parties' own privacy policies.

- Analysis cookies

These cookies allow the Publisher to track and analyse the behaviour of users when navigating the Website or using its services. The Publisher uses them to measure activity on the Website and create navigation profiles that enable it to make improvements based on the analysis of usage data.

This information collected through these cookies to keep track of the users' activity on the Website or on other related sites, includes: the IP address to derive the location from which the user is connected, the connection time, the device (wired or mobile) used to access the website, the operating system and browser used, the most frequently visited websites and the number of clicks. They also provide data on the user's browsing habits. The Publisher does not use other information such as the user's name, surname, e-mail address or postal address for the aforementioned purpose. Hence, the information handled does not allow the user to be uniquely identified.

GOOGLE ANALYTICS is a web analysis service provided by Google Ireland Limited. We use Google Analytics to monitor how visitors use the Website and to collate reports and help improve the Website. 4. Can You revoke your consent?

You may revoke or adjust your consent concerning cookies at any time, on the configuration panel referred to in section 3 and on the following link [Cookies](#), through common platforms that may exist for this purpose or through your browser.

a. Browser settings

If You wish to revoke your consent using the browsers You use, You must set it up as follows:

- (I) Microsoft Internet Explorer: In the "Tools" menu option, selecting "Internet Options" and accessing "Privacy".
- (II) Firefox, for Mac in the "Preferences" menu option, selecting "Privacy" by accessing the "Show Cookies" section, and for Windows in the "Tools" menu option, selecting "Options" by accessing "Privacy" and then "Use a personalised configuration for the browsing history".
- (III) Safari, under Safari, select "Preferences" and "Privacy".
- (IV) Google Chrome, under the option of the Chrome Tools or tab (for Mac), selecting "Options" ("Preferences" in Mac) by accessing "Advanced Configuration" and then entering "Privacy and security" and "Website Settings", and finally selecting "Cookies and site data".
